- You MAY arrive Friday afternoon from 12 NOON to 6PM or early Saturday morning 7AM and must be set up by 9AM
- You MUST unload and remove your car from unloading area before setting up your booth.
- You MUST remove all your trash at the end of the event from the event site.
- You MUST provide your own 10' x 10' tent with tent weights (required for safety), tables, and chairs.
- No electricity will be provided. You MUST provide your own battery-powered lights, if event ends after sunset.
- You MAY bring a small quiet generator if needed.

By signing this form as the 'Vendor/Exhibitor' you agree to all Blues At The Park and Manatee County policies and property rules.

LIABILITY FOR DAMAGE OR INJURY

The Exhibitor/Vendor shall be liable for damages to any property or injuries to any person which may arise from or be incident to the organization's activities, use, and occupation of the Property under this Agreement. Exhibitor/Vendor shall, at its own expense, promptly repair all damage to the Property caused by said organization. Exhibitor/Vendor shall defend, indemnify, and hold harmless Blues At The Park and Manatee County from any and all third-party claims, liabilities, loss or cause of action for property damage or bodily injury, including death, arising out of any act or omission of the Exhibitor/Vendor or any defect in the property or its improvements arising out of or in connection with its activities, use, and occupation of the Property under this agreement. Such indemnification shall include, but not be limited to, the payment of all claims, losses, and judgments of any nature whatsoever in connection therewith, and the payment of all related fees and costs, including any attorney's fees incurred by the County in connection with the Exhibitor/Vendor's activities arising out of the performance of this agreement.
